- 1) Meet to be held at The Louisa Centre, Stanley the Pool length is 25m of variable depth with 6 lanes & anti-wave lane ropes; a separate swim down facility is available
- 2) Colorado Electronic Timing will be in operation with scoreboard display. Times displayed are for information only
- 3) Age groups/Events will be:

9/Over years: 50/200m form strokes, 100/200 IM 10/Over years: 100m form strokes All events will be Heat Declared Winner

- 4) Entry times must be within the accompanying QTs
- 5) Entry times should be converted to 25m pool times by use of ASA Conversion Tables
- 6) Ages are as at 27 March 2011
- Entry fees: , £4.00 Sportsystem Entry Manager entries Coach passes cost £15.00 which includes programme, and refreshments Coaches will not be permitted on poolside without the necessary pass
- Entries must be submitted on the official entry disk or form and include the swimmer's full date of birth. Entries should be returned by the entry closing date: 21 February 2011, together the appropriate entry fee to: Philip Powell, Derwentside ASC, Blencathra, North Road, Dipton, Co Durham, DH9 9BB
- 9) Cheques should be made payable to "Derwentside ASC". A valid email address or SAE must be supplied for entry confirmation

10) Entries which are not countersigned by an official from the swimmer's club will be returned.

- 11) Derwentside ASC will **NOT** be responsible for any unaccompanied swimmers on the poolside. The responsibility falls on the club entering the swimmer, who should appoint an individual to be on the poolside i.e. an adult with a coach's pass
- 12) Heats will be seeded according to submitted entry times
- 13) Awards will be made to the first six in each age group: 9,10,11-12, 13-14
- 14) Swimmers will be permitted to compete for only one club during the meet
- 15) In the event of the meet being over-subscribed, rejections will be made from the fastest down in each age group: 11-12, 13-14
- 16) For safety reasons only swimmers who can perform an ASA competitive start may perform a shallow racing dive from the starting blocks. Where possible, over-the-top starts will be used during the meet. Swimmers are requested to remain in the water until asked to leave the pool
- 17) Admission for spectators will be £4 per day. Children, accompanied by adults, will be admitted free
- 18) No entry cards will be issued. Coaches or Team Managers should advise the recorders of any missing swimmers at least 45 minutes before the session start. Seeded heat start lists will be produced prior to the start time of the session. Complying with this condition will keep the number of empty lanes to a minimum
- 19) Poolside entries, £5, may be permitted if the meet has not been over-subscribed
- 20) Coaches/Team managers are responsible for ensuring competitors report to the marshalling area at the required time. Swimmers failing to report to the competitive marshals in time for the start of their race may not be allowed to compete
- 21) Anyone found damaging or misusing property or equipment at the host venue may be disqualified from any further involvement in the competition and may be subject to further action from the Pool Management
- 22) Neither Derwentside ASC nor Derwentside Trust for Sport and the Arts (Leisureworks) can be held responsible for loss or damage to spectators' or swimmers' property. Swimmers are advised to use the lockers (50p refundable) in the changing rooms and not to leave belongings unattended in the changing area or on poolside
- 23) Anyone wishing to use photographic equipment within the pool area must register at the spectators' desk beforehand
